Course Description

COT 3100 Applications of Discrete Structures. Credits: 3; Covers the mathematics of discrete events, i.e., events that involve distinct elements, finite structures of distinct elements, or finite sampled versions of continuous phenomena (such as movement).

Course Pre-Requisites / Co-Requisites

Prereq: MAC 2233, MAC 2311 or MAC 3472;

Coreq: COP 3504 or COP 3503.

Course Objectives

This course teaches you the fundamentals of logic, proof techniques, induction/recursion, counting, advanced counting (not as easy as it sounds!), relations, and more. These mathematical tools are essential to doing and understanding computer science / computer engineering.

The primary emphasis of the course is *mathematical reasoning and problem solving*. Equipping you with specific skills (such as tools for solving recurrence relations) is important, but only a secondary goal of this course. You won't find many plug-and-chug type of problems to solve. Many of the problems will require original thought. This is true both of homeworks as well as exams.

Course Instructor and Academic Term

Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
